2. Zoning Text Amendment—File No. [201000170-ZOA](#). Hearing date: December 8, 2010

A Zoning Ordinance Text Amendment amending Ada County Code Title 8 to delete references to grading permits and engineered grading permits; to provide for the deletion of maximum lot coverage in the R2 zoning district; to provide for the amending of standards for temporary uses exceeding 12 months' duration; to provide for temporary permits to have a beginning and end date; to provide that approved temporary living quarters may apply for new TLQ permit after 10 years; to provide for amendments to family and group day care facilities standards to delete requirement for commercial building permit.
